

Sebelas langkah penjimatan sektor awam yang diumumkan Perdana

Menteri adalah seperti berikut:

Eleven public sector saving measures announced by the Prime Minister is as follows:

1) Elaun keraian menteri-menteri dan timbalan-timbalan menteri akan dikurangkan sebanyak 10 peratus. Elaun keraian bagi pegawai kanan kerajaan Gred Jawatan Utama Sektor Awam C (JUSA C) ke atas akan dikurangkan sebanyak 5 hingga 10 peratus.

Entertainment allowance of ministers and deputy ministers will be reduced by 10 percent. Entertainment allowance for senior government officials Grade Designation Home Public Sector C (Jusa C) above will be reduced by 5 to 10 percent.

2) Pengurangan sebanyak 5 peratus kos utiliti elektrik di kesemua kementerian/jabatan/agensi/premis kerajaan.

Reduction of 5 percent in the whole costs of the electric utility ministries / departments / agencies / government premises.

3) Kemudahan bayaran tol bagi pegawai kanan kerajaan (Gred JUSA C ke atas) dikurangkan sebanyak RM50 hingga RM100 atau 30 peratus.

Toll facility for senior government officials (Grade Premier Grade C and above) reduced by RM50 to RM100 or 30 percent.

4) Permohonan baru bagi pengubahsuaian ruang pejabat kementerian/jabatan/premis kerajaan dibekukan.

New applications for modification of a ministry / department / premises were frozen

5) Mengetatkan pelantikan juru perunding atau consultant untuk projek- projek fizikal kerajaan termasuk dalam menjalankan feasibility study, di mana cadangan pelantikan hendaklah dikemukakan terlebih dahulu kepada Jawatankuasa Perancang Pembangunan Negara yang dipengerusikan Ketua Setiausaha Negara untuk kelulusan.

Tightened the appointment of the consultant or consultant for physical projects government including the conduct feasibility study, where the proposed appointment shall be submitted in advance to the Committee National Development Planning chaired by Chief Secretary to the Government for approval.

6) Mengurangkan penggunaan syarikat pengurusan acara atau event management serta pemberian saguhati (door gifts) atau cenderamata untuk penganjuran persidangan atau majlis-majlis kerajaan yang membabitkan anggota pentadbiran dan penjawat awam.

Reducing the use of event management or event management and consolation grant (door gifts) or souvenirs for organizing conferences or councils of government that affect members of the administration and civil servants.

7) Pindaan terhadap kelayakan tiket penerbangan domestik dan antarabangsa bagi penjawat awam. Sebagai contoh, kelayakan penerbangan sektor domestik bagi penjawat awam Gred JUSA C ke bawah ialah Kelas Ekonomi.

Amendments to the eligibility of domestic and international air tickets for civil servants. For example, eligibility for the domestic aviation sector civil servants JUSA C down is Economy Class.

8) Mengurangkan penyediaan makanan dan minuman semasa penganjuran persidangan, seminar, mesyuarat, kursus, bengkel atau sebarang acara rasmi kerajaan.

Reduce food and beverage preparation during organizing conferences, seminars, meetings, training courses, workshops or other formal events government.

9) Mengurangkan penggunaan kain pemedang (bunting dan banner) bagi penganjuran persidangan, seminar, mesyuarat, kursus, bengkel atau sebarang acara rasmi kerajaan.

Reducing the use of banners (bunting and banners) for organizing conferences, seminars, meetings, training courses, workshops or other formal events government.

10) Mengoptimumkan penggunaan ruang pejabat sedia ada untuk mengurangkan sewaan premis pejabat.

Optimizing the use of existing office space to reduce rental of office premises.

11) Mengaplikasikan pendekatan Strategi Lautan Biru Kebangsaan (NBOS) dengan mengoptimumkan penggunaan Pusat Latihan 1Malaysia atau 1Malaysia Training Center (1MTC) dan juga kemudahan-kemudahan di institusi-institusi latihan milik kerajaan bagi penganjuran kursus, seminar dan bengkel.

Applying the approach of the National Blue Ocean Strategy (NBOS) with optimize the use of the 1Malaysia or 1Malaysia Training Center Training Center (1MTC) and also the facilities owned training institutions government for organizing courses, seminars and workshops.
